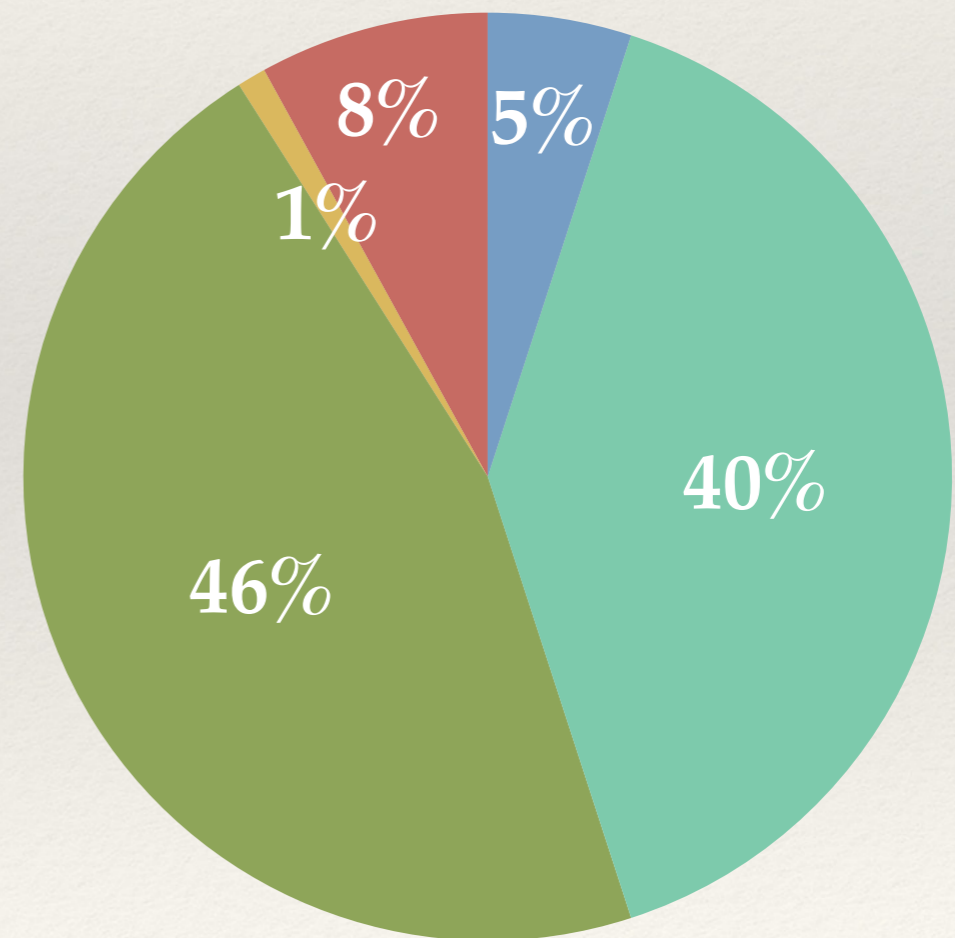

Year Ended December 31, 2018



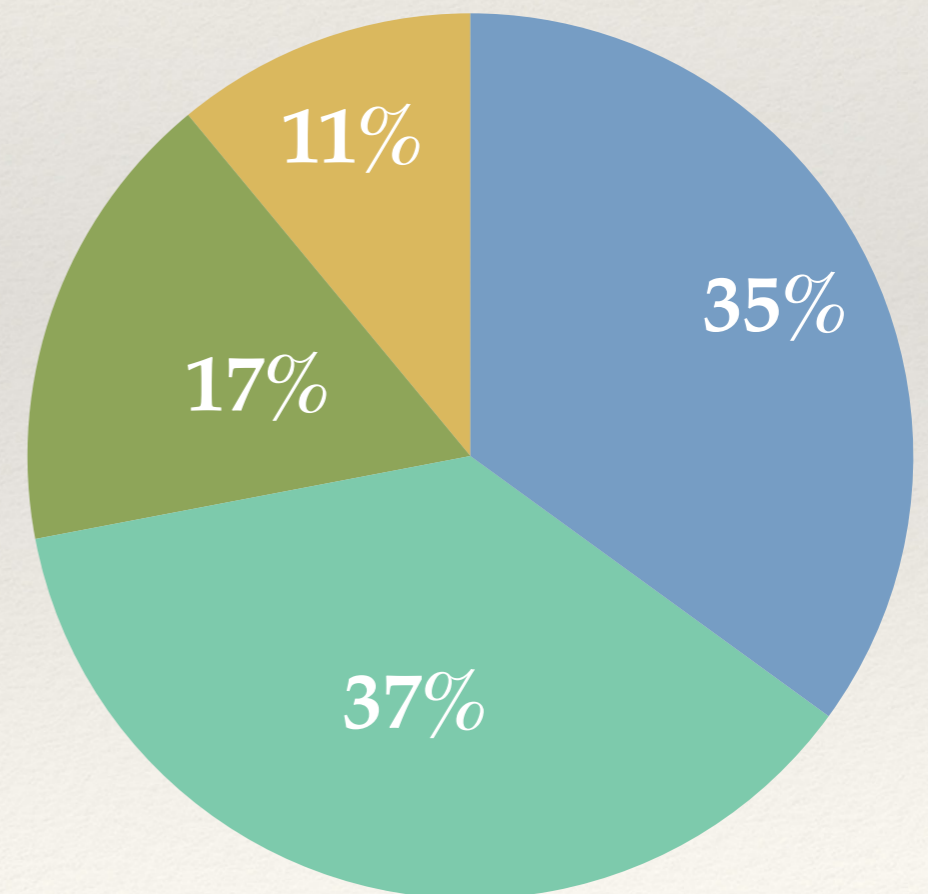
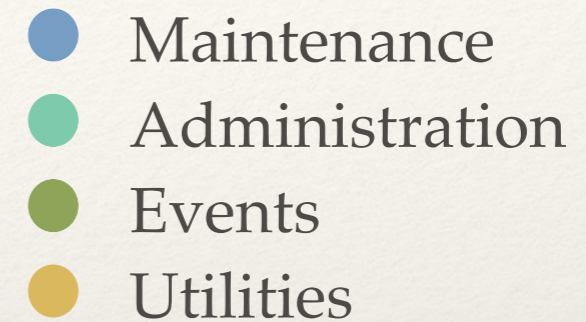
